5 Ply corrugated carton of each ply of 120 GSM / Virgin Kraft paper.

Total GSM of carton - Not less than 700 GSM.

Bursting strength of carton  $-9.5 \text{ Kg/cm}^2$  (minimum).

Partition Dimension  $-41 \times 31.5 \times 13.5$  cm with 3 ply partition suitably interlocked to hold for  $5 \times 4,500$  ml bottle each.

Flute - Corrugated box should be of narrow flute (N Flute).

Joint - Every box should be preferably single joints and not more than two joints. Flap joint will be glue joint (fungal free).

Stitching - Every box to be stitched using pairs of stainless steel pins (internally stapled) with an interval of 2 inches between each pair.

Flap - Flap should be uniformly meet but should not overlap each other. Flap when turned by  $45^{\circ}-60^{\circ}$  should not crack.

Printing - In accordance with our artwork.
