

5 Ply corrugated carton of each ply of 120 GSM / Virgin Kraft paper.

Partition- 45 x 22.5 x 9.5 cm \pm 1, 3 ply, suitably inter locked to hold 5x10, 100ml bottles each

Plate - Dimension – 45 x 22.5cm, 3 ply. Bursting strength 4.5kg/cm² Flute - Corrugated how should be

Flute - Corrugated box should be narrow flute (N flute).

Joint - Every box should be preferably single joints and not more than two joints. Flap joint will be glue joint (fungal free).

Stitching - Every box to be stitched using pairs of stainless steel pins (internally stapled) with an interval of 2 inches between each pair.

Flap - Flap should be uniformly meet but should not overlap each other. Flap when turned 45° -60° should not crack.

Number of colors -1 (Red)

Printing - In accordance with our artwork.
