TERMS AND CONDITIONS

1. Scope of the Work :

Supply and installation of SS pipeline and SS guard of Non-Betalactam plant.

2. Period on Completion :

All the work should be completed within 45 days from the date of receipt of work order / Handing over Site.

3. Compensation for delay :

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

4. Safety of adjoining properties:

The contractor or his authorized representatives should conduct all the operations necessary for the execution of works in such a manner that no inconvenience / damage is caused to the properties of other persons and owner.

5. Terms of Payment :

- 90% payment will be made against the completion of supply and erection. The balance 10% will be after one month of erection and submission of Bank Guarantee.
- The contractor shall execute an agreement within 10 days from date of issue of work order in 200 Rupees Kerala Stamp paper. There will be a security deposit amounting to 5 % of the total contract (Rs.8,500/-) value excluding taxes, which shall be

submitted by the contractor along with the agreement. Failure of the contractor in providing security deposit mentioned above and/or in returning contract copy duly signed in time shall make the tenderer liable for forfeiture of its EMD. The validity of security deposit should be one month after the completion of supply, Installation and commissioning of machines and submission of performance security.

- The 5% of Security Deposit, Deposited along with the agreement will be released 30 days after successful completion of the works including validation on submission of a performance bank guarantee for the equal amount which will be released after 12 months from the date of hand over if there is no rectification/deformity of work are found.
- It is the sole responsibility of the contractor to keep the materials supplied in safe custody and the owner is not liable to pay any compensation for the damages / losses sustained - if any. Freight, unloading, stacking handling at site are in contractors scope.
- Tax Deduction:- All statutory deduction other than GST like Income tax, E.S.I., P.F., KWWF, or any other government imposed liability shall be borne by the contractor (as applicable at the time of execution of job / payment of bills) and shall be deducted from each bill submitted by the contractor. Any other aspects not mentioned in this will be as per the store purchase manual /PWD manual.

6. Performance Security:

The contractor has to deposit a performance security amounting to 5% (Rs.8,500 /-) of the total contract value (if executed value is more than contract value than 5% of executed value) excluding taxes, to KSDP after completion of work. The validity of this performance security should be as per 60 days after defect liability period of 12 months.

7. General Conditions:

- i) You should work as per the Rules & Regulations applicable to Employees of the company.
- ii) The terms conditions of tender is an integral part of this work order.
- iii) You should be responsible for the welfare and safety of the Men employed by you inside the company.
- iv) Statutory deductions if any will apply to the Contract Value
- v) In case of dispute, jurisdiction will be Alleppey,Kerala
- vi) All safety measures should be taken during Erection & Commissioning.
- vii) Water and electricity will be supplied by KSDP free of cost at one point.
- viii) Special care is to be taken for cleanliness of the site & after the end of day's work the site should be cleaned immediately.
- ix) All tools and machines, scaffolding and labours required for the work is coming under the scope of contractor.
- x) Before starting the works you must produce the documents regarding welfare of employers such as ESI,EPF and insurance.
- xi) Your employees should wear all safety items/equipments such as helmet, goggles, safety belts, boots etc. Company will have no liability to employees entrusted by you with respect to safety measures.

Any items found to be having been executed with poor workmanship or materials of inferior quality then the contractor shall have to rectify / reconstruct the work as specified by owner/ consultant. No extra charge will be admissible in such case. If contractors fails to do so, the owner / consultant reserved the right to rectify reconstruct the through some other agency at the expenses of contractor.
