GENERAL TERMS AND CONDITIONS

Kerala State Drugs & Pharmaceuticals Limited, Kalavoor, Alappuzha, Kerala, is the Special Purpose Vehicle for setting up the Oncology Pharma Park. According to the guidelines issued by KIIFB, all new building projects funded by KIIFB with a total built-up area of 2500 sqm or more (excluding parking, basement area, and typical buildings) must be designed and constructed in compliance with IGBC and EDGE standards. Following a meeting with IGBC, it was confirmed that the project could be rated under the IGBC Green Factory Buildings Rating System. The project consultant has prepared the master plan, design and drawing for this project.

In light of the above, we invite you to submit a quote for the selection of a Green Building Consultant/Firm/Company for the following scope of work:

Scope of Work

The project aims for a Silver rating or above for IGBC Green Factory and EDGE-L1 norms. (Master Plan and area statement enclosed)

- 1. Design Assistance: Guidance to meet Green Building standards.
- 2. Design or Architectural Alterations: Suggestions for design or architectural changes as per applicable Green Building standards.
- 3. Preparation of KIIFB ESG Compliance Documents: Preparation of necessary documents in the format prescribed by KIIFB, including IGBC Feasibility Studies and EDGE Compliance Reports.
- 4. Material and Equipment Selection: Assistance for the project design team in selecting materials and equipment to meet IGBC and EDGE-L1 norms.
 - 5. Energy Performance Analysis and Modeling: Conducting energy performance analysis and model simulations in accordance with the latest IGBC and EDGE standards.

- 6. Whole Building Analysis: Comprehensive analysis of energy performance and climatic comfort compliance.
- 7. Solar Analysis: Optimization of shading and glazing areas through solar analysis.
- 8. Thermal/Energy Simulation: Detailed simulation to optimize building design and reduce conventional energy demand, determining the Energy Performance Index (EPI).

3. Firm or The IGBC Accredited Professional should Completed at least one project in India with IGBC certification silver rating or above.


