1. Scope of the Work :

Supply, Installation and Commissioning of SS Hood In Canteen and Duct Work

2. Period on Completion :

All the work should be completed within 20 days from the date of receipt of work order / Handing over Site.

2. Compensation for delay :

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

3. Terms of Payment :

100% payment will be released after completion of work

4. General Terms.

- i. Successful bidder should execute an agreement in Kerala stamp paper worth Rs. 200/- .
- ii. EMD will be released after completion of work.
- iii. Any failure in this direction will be liable to result in the forfeiture of the Earnest money already deposited and cancellation of the proposed contract and the contractor shall be liable to pay the Company the entire loss that may be caused to the company by the tenderer or re-arrangement of the work or otherwise consequent of the contractor's failure to execute the agreement or executing the work.
- iv. It must be understood that on no account the rate once fixed will be increased.

- v. KSDP will provide power supply for the unit.
