Kerala State Drugs and Pharmaceuticals Ltd, Kalavoor, invited sealed quotations from competent persons/ experienced organizations for the work of annual maintenance of 2 TPH IBR and 1.5TPH IBR Boiler and making it fit for conducting hydraulic test in the presence of the Boiler Inspector, Factories and Boilers.

Scope of work

- Boiler water side portion chemical cleaning and wash with chemical neutralizer.
- Dismantle all the valves and mountings and isolate the boiler.
- All the smoke tubes are to be cleaned by means of round brush up to the visibility of the parent metal.
- Clean the boiler from the water side as well as the flue side and arrange the boiler for open inspection by the boiler Inspector.
- Maintenance of the valves and mountings and re-fixing the same on to the boiler.
- Prepare the boiler ready for the hydraulic test.
- Conduct the hydraulic test in the presence of the Boiler Inspector.
- Reassembly all the service lines, stream lines, etc. and demonstrate the performance.
- The cost of replacing of gaskets, gland packing, necessary spares, cost of consumables for required cleaning of the boilers tubes, pipelines etc and all expense required for the complete annual maintenance and making the boiler ready for annual inspection and to arrange the inspection.
- Any other works necessary/ required for annual inspection.

Eligibility

- Should be a competent person/ Licensed organizations under Factories and Boilers, Kerala.



Period of completion:

- All the work should be completed within 10 days from the date of receipt of work order.

Term of Payment:

- 50% of the payment will be made after the successful completion of the annual inspection by Factories and Boilers Inspector. Balance 50% shall be released after receiving the Boiler renewal from the Inspectorate of Factories and boilers.
- Necessary taxes will be deducted from your bill as required.

- The amount quoted will be inclusive of the cost of replacing of gaskets , gland packing , necessary spares, cost of consumables for required cleaning of the boiler tubes, pipelines etc, and all expense required for the complete annual maintenance and making the boiler ready for annual inspection.
