## TERMS AND CONDITIONS

### **1. Scope of the Work :**

To Hire Vehicle with Driver and fuel for the transportation of water from KWA HW Subdivision Thycattussery Tanker pumping station to KSDP.

### **2. Period on Completion :**

This work order will be valid until the Permanent water connection from KWA reaches KSDP. KSDP reserve all the right to cancel the order at any time without any notice.

### **3. Terms of Payment :**

1. Bill will be processed **once in a fortnight**. The payment will be credited with in the next 15 days once the bill is processed.
2. The applicable tax as per Law/Rule will be deducted from the bill.
3. The contractor shall execute an agreement within 10 days from date of issue of work order in 200 Rupees Kerala Stamp paper.
4. EMD will be released after execution of agreement.

### **4. General Conditions:**

- I. This tender pertains to the transportation of water from KWA HW Subdivision Thycattussery to KSDP.
- II. The vehicle used for transporting water must have a minimum carrying capacity of 10 KL per trip.
- III. KSDP will provide two (2) 5000-liter HDPE water tanks.
- IV. Only HDPE tanks are permitted for water transportation; no other types of tanks are allowed.
- V. The water tank used for transportation from KWA to KSDP must not be used for any other purpose.
- VI. The vehicle owner is responsible for arranging the placement of the tank on their vehicle.
- VII. After each day's transportation, the vehicle used for water transport must remain within the KSDP premises and will not be permitted to leave. For maintenance/repair/service if any it will be permitted.
- VIII. The cost of the water will be borne by KSDP.

- IX. The vehicle owner must make the arrangement to clean the tank and ensure the sanitization of the HDPE tank at least once every week.
- X. Any damage caused to the tank during transportation must be repaired or replaced at no cost to KSDP. If owner of vehicle fails to do so, the cost of the tank will be deducted from the payment.
- XI. Payment will be based on the actual quantity of water delivered to KSDP.
- XII. A daily minimum of 40,000 liters of water must be delivered to KSDP. The volume may vary (Increase or Decrease) depending on daily requirements.
- XIII. In case of vehicle breakdown, the vehicle must arrange a replacement vehicle without delay.
- XIV. The vehicle and driver must comply with the rules and regulations of the Motor Vehicles Department (MVD). Any fines incurred during transportation will be the sole responsibility of the owner of vehicle, and KSDP will not be liable for any violations.
- XV. The driver must be available on-demand for water transportation as required by KSDP.
- XVI. The owner of vehicle assumes full responsibility for the safety, maintenance, and security of the vehicle and driver.
- XVII. The owner of vehicle is responsible for filling the water tanks at KWA Thycattussery and transferring water to the underground water tank at KSDP.
- XVIII. The owner of vehicle must provide and maintain pump for transferring water from the vehicle to the underground water tank at KSDP.
- XIX. All expenses, including vehicle charges, driver's salary, allowances, Bata, fuel, etc., must be included in the rate per liter quoted by the contractor.
- XX. KSDP reserves the right to cancel the order at any time.
- XXI. The owner of vehicle must comply with all rules and regulations applicable to KSDP employees while working within the company premises.
- XXII. The owner of vehicle is responsible for the welfare and safety of its employees working inside the company premises.
- XXIII. Statutory deductions, if any, will apply to the contract value.
- XXIV. In case of any dispute, the jurisdiction shall be the courts in Alleppey, Kerala.
