

100 bottles packed in single corrugated box in 2 rows with top, bottom and center pad

DIMENSIONS: L X B X H 45X 22.5 X 21 cm ±2 (Outer dimension)

7 Ply corrugated carton of each ply of 120 GSM / Virgin Kraft paper.

Total GSM of carton – Not less than 1000 GSM.

Bursting strength of carton $-11 \text{ Kg/cm}^2(\text{minimum})$.

Partition: 44 x 22 x 7.5 cm, 3 ply, suitably inter locked to hold 5x10, 60ml bottles each.

Plate: Dimension – 44 x 22cm, 3 ply. Bursting strength 4.5kg/cm²

Flute - Corrugated box should be narrow flute (N flute).

Joint - Every box should be preferably single joints and not more than two joints. Flap joint will be glue joint (fungal free)

Stitching - Every box to be stitched using pairs of stainless steel pins (internally stapled) with an interval of 2 inches between each pair.

Flap - Flap should be uniformly meet but should not overlap each other. Flap when turned 45°

 -60° should not crack.

Number of colors - 1 (Red)

Printing - In accordance with our artwork.

Carton number (Carton No: 4050) to be printed on specified area.
