TERMS AND CONDITIONS

1. Scope of the Work:

Integration of Equipment work at LVP/SVP plant.

2. Period on Completion:

This work order will be valid until 45 days from date of handing over of site. This work is in connection with machine integration. Hence related to the visit of machine supplier. KSDP reserve all the right to cancel the order at any time without any notice.

3. Compensation for delay:

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

4. Safety of adjoining properties:

The contractor or his authorized representatives should conduct all the operations necessary for the execution of works in such a manner that no inconvenience / damage is caused to the properties of other persons and owner.

5. Terms of Payment:

- 90% payment will be made according to progress of work against the completion of supply and erection. The balance 10% will be after one month of commissioning of machine and submission of perform security .if contractor fail to submit perform security then the 5% will be withheld from this payment and it will be released after defect liability period.
- It is the sole responsibility of the contractor to keep the materials supplied in safe custody and the owner is not liable to pay any compensation for the damages / losses

- sustained if any. Freight, unloading, stacking handling at site are in contractors scope.
- Tax Deduction:- All statuary deduction other than GST like Income tax, E.S.I., P.F., KWWF, or any other government imposed liability shall be borne by the contractor (as applicable at the time of execution of job / payment of bills) and shall be deducted from each bill submitted by the contractor. Any other aspects not mentioned in this will be as per the store purchase manual /PWD manual.

6. Performance Security:

The contractor has to deposit a performance security amounting to 5% of the total contract value (if executed value is more than contact value than 5% of executed value) excluding taxes, which shall be submitted by the contractor to the KSDP after commissioning of the equipment. The validity of this performance security should be as per 60 days after defect liability period of 12 months perform security & BG as per purchase manual.

7. General Conditions:

- I. This tender pertains to integration of equipment at LVP/SVP plant.
- II. You should work as per the Rules and Regulations applicable to employees of the company.
- III. All tools and machines, scaffolding and labours required for the work is coming under the scope of contractor.
- IV. Before starting the works you must produce the documents regarding welfare of employees such as ESI, EPF and insurance.
- V. You should be responsible for the welfare and the safety of the men employed by you inside the company.
- VI. Your employees should wear all safety items/ equipments such as helmet, goggles, safety belts, boots etc. Company will have no liability to employees entrusted by you with respect to safety/welfare measures.
- VII. All safety measures should be taken during the works.

- VIII. Statutory deductions if any apply to the contract value.
 - IX. In case of any damage happens the entire cost for rectification at the risk and cost of the contractor.
 - X. Water and electricity will be supplied free of cost by KSDP at one point.
 - XI. KSDP reserves the right to cancel the order at any time.
- XII. In case of any dispute, the jurisdiction shall be the courts in Alleppey, Kerala.
