## **TERMS AND CONDITIONS**

Kerala State Drugs and Pharmaceuticals Ltd, Kalavoor, invited sealed tender from competent persons/ organizations for conducting the steam test in the presence of the boiler inspector and the work of annual maintenance of 2 TPH IBR and 1.5TPH IBR Boiler and making it fit for conducting hydraulic test in the presence of the Boiler Inspector, Factories and Boilers.

### **1.Scope of work**

#### **Part A:**

1. Steam Test to be conducted for 2 Ton & 1.5 Ton boiler in the presents of boiler inspector.
2. Necessary arrangement to conduct inspection of steam test by factories and boiler inspector.
3. Part A and Part B work has to be conducted separately

#### **Part B (This has to be conducted after getting approval for steam test Part A)**

1. Boiler water side portion chemical cleaning and wash with chemical neutralizer.
  2. Dismantle all the valves and mountings and isolate the boiler.
  3. All the smoke tubes are to be cleaned by means of round brush up to the visibility of the parent metal.
  4. Clean the boiler from the water side as well as the flue side and arrange the boiler for open inspection by the boiler Inspector.
  5. Maintenance of the valves and mountings and re-fixing the same on to the boiler.
  6. Prepare the boiler ready for the hydraulic test.
  7. Conduct the hydraulic test in the presence of the Boiler Inspector.

8. Reassembly all the service lines, stream lines, etc. and demonstrate the performance.
9. The cost of replacing of gaskets, gland packing, necessary spares, cost of consumables for required cleaning of the boilers tubes, pipelines etc and all expense required for the complete annual maintenance and making the boiler ready for annual inspection and to arrange the inspection.
10. Any other works necessary/ required for annual inspection.
11. Annual Maintenance works of the 2 boilers should be done on separate days to avoid inconvenience of running the plant.
12. The maintenance works should be done on the dates proposed by KSDP which will be closer to the factories and boilers inspection date.

## **2. Period on Completion :**

1. Steam test should be completed within 15 days
2. Annual inspection should be completed within one month

## **3. Terms of Payment :**

1. Payment for conducting the steam test (Part A) will be released upon getting confirmation from factories and boiler inspector.
2. Payment for annual inspection of boilers  
100% will be released after receiving the renewal certificate from Factories and boilers for both boilers.
3. Necessary taxes will be deducted from your bill as required.
4. GST will be extra based on actuals.

## **4. ELIGIBILITY**

Should have valid boiler erector / repairers certificate issued by Directorate of Factories and Boilers.

## **5. General Condition**

1. The amount quoted for the work should be exclusive of applicable GST.
2. The amount quoted will be inclusive of the cost of replacing of gaskets , gland packing , necessary spāres, cost of consumables for required cleaning of the boiler tubes, pipelines etc, and all expense required for the complete annual maintenance and making the boiler ready for annual inspection.
3. Electrical power supply and water will be provided by the company.
4. If required, the bidder can visit the factory and collect necessary details regarding the boiler and its condition.
5. All the work as per scope mentioned should be conducted.
6. Co ordinate with Factories and boiler inspection and conducting steam test and inspection.
7. All work necessary and required for steam test to be considered and included in the rate.
8. EMD amount will be released after completion of work.
