TERMS AND CONDITIONS

Kerala State Drugs and Pharmaceuticals Ltd, Kalavoor, invited sealed tender from registered persons/organizations with valid certificate issued by Directorate of Factories and Boilers, for IBR Steam Line Work.

1.SCOPE OF WORK

1. Design and preparation of Isometric drawing.
2. Supply and Fabrication and erection of 38 Meter IBR steam line from header to machine.
3. Supply and Fabrication and erection of PRV station
4. i) 50 NB IBR pipe Make TATA or JINDAL.
ii) PRV Make Darling Muesco/Samson/Spirax/Thermax/Forbes Marshall.
5. Supply, Fabrication and erection of TD Trap line system.
6. Insulation of the Steam line.
7. Material inspection by factories and boiler inspector.
8. Open test ,Hydraulic test must be done.
9. The contractor must arrange inspection and obtain the approval from the factories and boilers department for the steam line.
10. Statutory fee will be paid by KSDP.

2. GENERAL TERMS.

- i. You are directed to attend this office within 7 days from the date of issue of work order with a Kerala stamp paper worth Rs 200/- and execute necessary agreement for the work

- ii. Your Bid will be rejected if agreement is not executed within 7 days from the date of issue of Selection Notice and work will be awarded to the next lowest Tenderer
- iii. EMD will be released after completion of work
- iv. Any failure in this direction will be liable to result in the forfeiture of the Earnest money already deposited and cancellation of the proposed contract and the contractor shall be liable to pay the Company the entire loss that may be caused to the company by the tenderer or re-arrangement of the work or otherwise consequent of the contractor's failure to execute the agreement or executing the work.
- v. It must be understood that on no account the rate once fixed will be increased.
- vi. The amount quoted for the work should be exclusive of applicable GST.

3. PERIOD ON COMPLETION :

1. The work should be completed with in 15 days.

4. ELIGIBILITY

Should have valid certificate issued by Directorate of Factories and Boilers.

5. DEFECT LIABILITY PERIOD :

Defect liability period will be 1 year from the date of completion of the work

6. COMPENSATION FOR DELAY :

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract

value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

7. TERMS OF PAYMENT :

1. 95% of the payment will be released after completion of work and getting approval from factories and boilers department.
2. 5% of the payment will be released after the defect liability period.

Or

Upon submission of 5% of executed value as Performance Guarantee in the format mentioned in store purchase manual.

3. GST will be extra based on actuals.

8. GENERAL CONDITIONS:

You should work as per the Rules & Regulations applicable to Employees of the company.

- i) All the work as per scope mentioned should be conducted.
- ii) If required, the bidder can visit the factory and collect necessary details regarding the work.
- iii) EMD amount will be released after completion of work.
- iv) GST will be paid extra as per actual.
- v) You should be responsible for the welfare and safety of the Men employed by you inside the company.
- vi) Statutory deductions if any will apply to the Contract Value
- vii) In case of dispute, jurisdiction will be Alleppey, Kerala
- viii) All safety measures should be taken during Erection & Commissioning.
- ix) Water and electricity will be supplied by KSDP free of cost at one point.

- x) Special care is to be taken for cleanliness of the site & after the end of day's work the site should be cleaned immediately.
