TERMS AND CONDITIONS

Kerala State Drugs and Pharmaceuticals Ltd, Kalavoor, invited sealed tender from competent persons/ organizations for Supply, Fabrication and Erection of Trap systems and other works.

1.Scope of work

1. Fabrication& Erection of Thermodynamic Trap system at 5 defined set of locations inside LVP/SVP plant
2. Setting up of new valve in pipelines at 5 defined set of locations inside LVP/SVP plant
3. Insulation of new & old steam pipelines in the machine areas
4. Setting up of new Pressure Gauges in pipelines in each plant (6 Nos)

5. SUPPLY OF MATERIALS

- a) SS 304 & MS Pipes
- b) Flanges & bends
- c) SS Ball valves
- d) SS Thermodynamic Trap
- e) SS Pressure Gauge with SS Syphon
- f) Teflon Gasket
- g) All consumables required for the job
- h) Insulation Materials -Aluminium sheet & Wool
- i) Transportation of materials

2. period on completion :

All the work should be completed within 30 days from the date of issue of work order / handing over site.

3.Compensation for delay :

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

4. Safety of adjoining properties:

The contractor or his authorized representatives should conduct all the operations necessary for the execution of works in such a manner that no inconvenience / damage is caused to the properties of other persons and owner.

5. Terms of Payment :

- 90% payment will be made according to progress of work against the completion of supply and erection. The balance 10% will be after one month of commissioning of machine and submission of perform security.if contractor fail to submit perform security then the 5% will be withheld from this payment and it will be released after defect liability period.
- It is the sole responsibility of the contractor to keep the materials supplied in safe custody and the owner is not liable to pay any compensation for the damages / losses sustained - if any. Freight, unloading, stacking handling at site are in contractors scope.

- Tax Deduction:- All statutory deduction other than GST like Income tax, E.S.I., P.F., KWWF, or any other government imposed liability shall be borne by the contractor (as applicable at the time of execution of job / payment of bills) and shall be deducted from each bill submitted by the contractor. Any other aspects not mentioned in this will be as per the store purchase manual /PWDmanual.

6.Performance Security:

The contractor has to deposit a performance security amounting to 5% of the total contract value (if executed value is more than contract value then 5% of executed value) excluding taxes, which shall be submitted by the contractor to the KSDP after commissioning of the equipment. The validity of this performance security should be as per 60 days after defect liability period of 12 months perform security & BG as per purchase manual.

7. General Terms.

- An agreement to be executed in Kerala stamp paper worth Rs 200/- within 14 days of issue of work order.
- Your order will be cancelled if agreement is not executed within 14 days from the date of issue of Selection Notice and work will be awarded to the next lowest Tenderer.
- EMD will be released after completion of work
- Any failure in this direction will be liable to result in the forfeiture of the Earnest money already deposited and cancellation of the proposed contract and the contractor shall be liable to pay the Company the entire loss that may be caused to the company by the tenderer or re-arrangement of the work or otherwise consequent of the contractor's failure to execute the agreement or executing the work.
- It must be understood that on no account the rate once fixed will be increased.

8. General Condition

- I. You should work as per the Rules & Regulations applicable to Employees of the company.
- II. You should be responsible for the welfare and safety of the Men employed by you inside the company.
- III. Statutory deductions if any will apply to the Contract Value
- IV. In case of dispute, jurisdiction will be Alleppey, Kerala
- V. All safety measures should be taken during Erection & Commissioning.
- VI. Water and electricity will be supplied by KSDP free of cost at one point.
- VII. Special care is to be taken for cleanliness of the site & after the end of day's work the site should be cleaned immediately.
- VIII. Required tools, equipments etc. are in contractor's scope.
- IX. Before starting the works you must produce the documents regarding welfare of employers such as ESI, EPF and insurance.
- X. Your employees should wear all safety items/equipments such as helmet, goggles, safety belts, boots etc. Company will have no liability to employees entrusted by you with respect to safety measures.
- XI. GST will be paid extra as per actual.
- XII. The amount quoted for the work should be exclusive of applicable GST.
