5 Ply corrugated carton of each ply of 120 GSM / Virgin Kraft paper.

Partition Dimension – 41 X 31.5 X 13.5cm with 3 ply partition suitably interlocked to hold for 5 X 4,500 ml bottle each.

Flute - Corrugated box should be of narrow flute (N Flute).

Joint - Every box should be preferably single joints and not more than two joints. Flap joint will be glue joint (fungal free).

Stitching - Every box to be stitched using pairs of stainless steel pins (internally stapled) with an interval of 2 inches between each pair.






