- Autoclave Validation using 18- channel & 48 channel sensors in LVP/SVP/Ophthalmic plant at KSDP, Alappuzha as per applicable validation protocols and regulatory standards.
- Validation to be performed with temperature mapping probe at different location of the chamber and one pressure transmitter for pressure recording up to sterilization time.
- Record and print out of the parameter and report.
- Hard copy to be submitted.
- The desired temperature rate is up to 121°C during the complete cycle and holding period up to sterilization time.
