5 Ply corrugated carton of each ply of 120 GSM / Virgin Kraft paper.

Bursting strength of carton -9.5 Kg/cm^2 (minimum).

Partition Dimension $-41 \times 31.5 \times 13.5 \text{cm}$ with 3 ply partition suitably interlocked to hold for $5 \times 4,500 \text{ ml}$ bottle each.

Flute - Corrugated box should be of narrow flute (N Flute).

Joint - Every box should be preferably single joints and not more than two joints. Flap joint will be glue joint (fungal free).

Stitching - Every box to be stitched using pairs of stainless steel pins (internally stapled) with an interval of 2 inches between each pair.

Flap - Flap should be uniformly meet but should not overlap each other. Flap when turned by $45^{0}-60^{0}$ should not crack.
