Material – 5 Ply (Board with E flute type). Total GSM 920 GSM with coated Duplex board Grade 2, as top layer and other 4 layer are Virgin kraft paper of 150 GSM each with E flute with 230 GSM top coated white gray back board.

Bursting strength: 9 Kg/cm²

PARTITION DIMENSION: 135 x 135 x 50mm with 3ply partition. (5 x 5 compartments)
