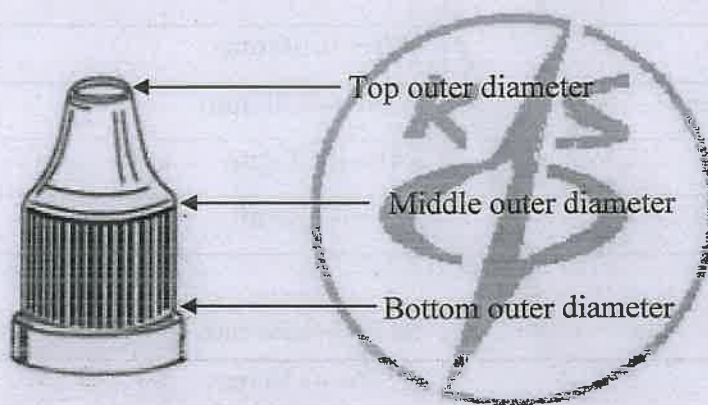


Figure 1: Ophthalmic Bottle
Cap

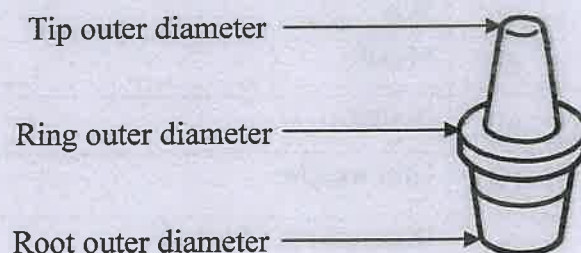







Figure 2: Ophthalmic Bottle
