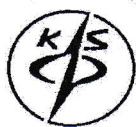

PARTITION DIMENSION: 135 x 135 x 55mm with 3ply partition. (4 x 4 compartments).






