

TERMS AND CONDITIONS

1. Scope of the Work :

Supply and Installation of Fire Pipeline and Accessories Non-Beta Plant at KSDP, Alappuzha".

2. General Terms.

- i. You are directed to attend this office within 7 days from the date of issue of work order with a Kerala stamp paper worth Rs 200/- and execute necessary agreement for the work
- ii. Your Bid will be rejected if agreement is not executed within 7 days from the date of issue of Selection Notice and work will be awarded to the next lowest Tenderer
- iii. EMD will be released after completion of work
- iv. Any failure in this direction will be liable to result in the forfeiture of the Earnest money already deposited and cancellation of the proposed contract and the contractor shall be liable to pay the Company the entire loss that may be caused to the company by the tenderer or re-arrangement of the work or otherwise consequent of the contractor's failure to execute the agreement or executing the work.
- v. It must be understood that on no account the rate once fixed will be increased.
- vi. The amount quoted for the work should be exclusive of applicable GST.
- vii. All materials, tools machines, scaffolding, and labours required for working is coming under the scope of contractor.

3. Period of Completion :

This work order will be valid until 30 days from date of handing over of site. KSDP reserve all the right to cancel the order at any time without any notice.

4. Defect liability period :

Defect liability period will be 1 year from the date of completion of the work

5. Compensation for delay :

Time is the essence of the contract. If the contractor fails to complete the work and clear the site on or before the dates fixed for the completion, he shall without prejudice be liable to pay liquidation damage (LD), i.e. 1 (one) percent of the contract value for every week that the whole or the part of work remains incomplete. For the purpose of this condition, the contract value shall be total value of quantities of items in the contract at contract rates plus algebraic sum of the subsequent work ordered. However, the total amount of LD to be paid under this condition shall not exceed 10 (ten) percent of the contract value.

6. Safety of adjoining properties:

The contractor or his authorized representatives should conduct all the operations necessary for the execution of works in such a manner that no inconvenience / damage is caused to the properties of other persons and owner.

7. Terms of Payment :

95% payment will be released after the completion of work. 5% will be released after defect liability period.

It is the sole responsibility of the contractor to keep the materials supplied in safe custody and the owner is not liable to pay any compensation for the damages / losses sustained - if any. Freight, unloading, stacking handling at site are in contractor's scope. Tax Deduction:- All statutory deduction other than GST like Income tax, E.S.I., P.F., KWWF, or any other government imposed liability shall be

borne by the contractor (as applicable at the time of execution of job / payment of bills) and shall be deducted from each bill submitted by the contractor. Any other aspects not mentioned in this will be as per the store purchase manual /PWD manual.

9. General Conditions:

- I. You should work as per the Rules and Regulations applicable to employees of the company.
- II. All tools and machines, scaffolding and labours required for the work is coming under the scope of contractor.
- III. Before starting the works you must produce the documents regarding welfare of employees such as ESI, EPF and insurance.
- IV. You should be responsible for the welfare and the safety of the men employed by you inside the company.
- V. Your employees should wear all safety items/ equipments such as helmet, goggles, safety belts, boots etc. Company will have no liability to employees entrusted by you with respect to safety/welfare measures.
- VI. All safety measures should be taken during the works.
- VII. Statutory deductions if any apply to the contract value.
- VIII. In case of any damage happens the entire cost for rectification at the risk and cost of the contractor.
- IX. Water and electricity will be supplied free of cost by KSDP at one point.
- X. KSDP reserves the right to cancel the order at any time.
- XI. In case of any dispute, the jurisdiction shall be the courts in Alleppey, Kerala.


