1	Description	An almost white or colourless crystals, dry crystalline powder, odourless, taste sweet
2	Acidity or alkalinity	The solution is colourless and not more than 0.6mL of 0.01M sodium hydroxide is required to change the colour of the solution to pink.
3	Identification	An orange precipitate is produced.
