2	Solubility	Freely soluble in chloroform , soluble in ethanol (95%) and very slightly soluble in water.
3	Identification	A. To a quantity of the contents of the capsules containing 50mg of Omeprazole in an 100mL volumetric flask and add about 70mL of 0.1M NaOH. Mix in an ultrasonic bath for about 5 minutes and heat on a water bath for 10 minutes. Cool, make up to volume with 0.1M NaOH and filter. Dilute 2mL of the filtrate to 100mL with 0.1M NaOH. When examined in the range 230nm to 360nm, the resulting solution shows absorption maximum at about 276nm and 305nm. B. By HPLC
